**NURSING HOME INFORMATION FOR RESIDENTS AND THEIR FAMILIES**

Both the New York State Department of Health (NYSDOH) and the U.S. Department of Health and Human Services Centers for Medicare & Medicaid Services (CMS) maintain information on nursing homes for that includes performance on quality measures, inspection results, complaints, citations and enforcement actions as well as any penalties that have been imposed on a given nursing home.

- Once you are on the DOH website, you can search for our facility by searching for the name of our facility in the window "Search for Zip, City, Name" that appears within the map of New York State on that page. The name of our facility should then show to the left of the map. Clicking on the name of our facility will bring you to our facility page, and you can then choose the third tab, labeled "Inspections" to find information regarding complaints, citations, or enforcement actions action the facility.
